**DIRECTIONS FOR USE:** Spray DermaCen Perineal Wash directly to where urine, feces, or emesis has soiled skin. Remove bulk of feces or emesis. Spray additional product on warm, wet wash cloth and gently wipe skin of all remaining residue. Use clean cloth surface as necessary. Pat dry. To deodorize soiled pads, linens, and clothing, follow same instructions as above before laundry procedures.

**STOMA SITES:** After removing bag, spray on soiled areas of peristomal skin. Gently clean and pat dry. For ostomy appliance, spray a small amount into new appliance bag prior to application. Spray enough to cover inside walls to maintain appliance freshness and control odors.
